HISTORICAL BACKGROUND

Trade Guilds, forerunners of the Livery Companies, can be traced back to the Middle Ages. Guilds are not unique to the United Kingdom - they, or their successors, can be found in France, Germany, Switzerland, Belgium, Denmark and Sweden - to name but a few. Whilst their relative power varied from one country to another, the traditional aims were essentially those of regulating trade and assuring quality before the age of automated production, the regulation and education of apprentices and the welfare of members of the trade should they fall into ill health or on hard times.

The Feltmakers (the Hatters) can trace their roots back to the 12th century. In 1501 the Hurers (makers of shaggy caps) amalgamated with the Cappers and Hatters and joined the Haberdashers who already counted many Feltmakers amongst their members. After some years they sought to become a constituted body in their own right under the name of Feltmakers.

Queen Elizabeth I was petitioned in 1577 and 1583 for a Charter for the Feltmakers but this was vigorously opposed by the Haberdashers, and it was not until 1604 that the Feltmakers were Incorporated by Letters Patent from King James I in the name of Masters, Wardens and Commonalty of the Art or Mystery of Feltmakers of London. King Charles II granted a Charter of Confirmation in 1667, confirmed again by King George III in 1772. In 1733 the Company was granted livery by the Court of Aldermen.

Although the Feltmakers do not have their own Hall, during the 18th century they commonly used the Pewterers' Hall and the Guildhall for meetings. Today the Livery uses a number of different Halls.

The Feltmakers have had similar Arms since their inception. Formal Arms were granted in 1946 by the College of Arms with the following description:

Argent, a dexter hand appaumé couped at the wrist gules between two hatbands nowed [knot- ted] azure, in chief a hat sable banded azure. Crest: On a wreath of the colours a dexter arm embowed proper holding in the hand a hat sable banded azure.

The motto - 'Decus-et-Tutamen', translated as 'decoration and protection', was adopted in 1787.

During the Feltmakers' long history the Company has produced three Lord Mayors of London, Sir Louis Newton in 1923 and Sir Hugh Wontner in 1973 and Alderman Sir William Russell who served two terms in 2019 and 2020. In the late 19th century the Company had many famous politicians in their membership including W.H. Smith, First Lord of the Treasury and First Lord of the Admiralty, Sir Stafford Northcote, President of the Board of Trade and First Lord of the Treasury and the Right Honourable George Hunt, Chancellor and First Lord of the Admiralty. In all there were 11 prominent Victorian MPs in the Feltmakers.

particularly successful and most of the design colleges enter the work of their best pupils. In the celebratory year of 2004 the competition was opened to colleges in Europe and the value of the prizes doubled.

The late Past Master Arthur E. Hemens presented the Company with a freehold property in Consett and also set up the Feltmakers' Charitable Foundation to which he left a substantial legacy. This has been added to by many other generous donors over the last 20 years. Incoming Liverymen are now required to make annual donations to the Foundation. This has enabled the Company to extend its charitable activities considerably.

During 1994 a Feltmakers' Society was established to encourage the active participation of newer Feltmakers and to help them meet other members. This has flourished and its sporting activities now include cricket, tennis, horse racing, clay pigeon shooting, golf and swimming - many of these raising money for charity.

The Worshipful Company of Feltmakers of London is alive and well.

GENERAL INFORMATION

SOCIAL FUNCTIONS

In June, the Annual Banquet, to which partners are invited, is usually held at the Mansion House by kind permission of the Lord Mayor. Liverymen are encouraged to invite guests.

Livery Dinners are held on the first Friday in October and the first Monday in April. Guests, both ladies and gentlemen, are most welcome but not spouses or partners.

LORD MAYOR'S CEREMONIAL HAT

For some years now the Company has been privileged to present The Right Honourable The Lord Mayor with his ceremonial hat. Each year, shortly after the Lord Mayor has taken office, the Master, Wardens and Clerk visit the Mansion House and, at a brief ceremony, formally give the hat to the Lord Mayor.

GOLF

The Feltmakers' Company is a subscribing Member of the Livery Companies' Golfing Society and enters a team of four at the Society's Annual Meeting at Wentworth Park for the "Prince Arthur of Connaught Cup". Liverymen wishing to be considered for inclusion in the team should advise the Clerk. A Feltmakers' Golf day was inaugurated in 1994 and is now in the calendar, usually in May.

TENNIS

In 1995 the Company introduced the Inter-Livery Tennis Competition which it continues to organise annually.

FELTMAKERS' LODGE

The Feltmakers' Lodge, No. 3839, was founded in 1918 by Members of the Feltmakers' Company and is one of several City Livery Lodges. The Lodge meets four times a year at the Butchers' Hall, 87 Bartholomew Close, EC1. Liverymen interested should apply for information from Past Master Commander Ian Wellesley-Harding, RN.

NEW LIVERYMEN

Applicants may be introduced by a Liveryman but must be proposed and seconded by Members of the Court. Before acceptance, applicants will be requested to attend an Interviewing Committee. Liverymen wishing to introduce a person for admission to the Livery should, in the first instance, communicate with the Clerk.

CITY LIVERY CLUB

The Club, which now meets at the Insurers' Company Hall at 20 Aldermanbury, EC2, was founded in 1914 for Liverymen of the City. Applications for Membership should be made to the Hon. Secretary at the Club.

UNITED GUILDS SERVICE AT ST PAUL'S CATHEDRAL

This service is for Liverymen of the City and is held on the Friday, two weeks before Good Friday. All City Companies are represented and pews are reserved for each Company. The Master and Members of the Court attend. Liverymen wishing to be present should apply to the Clerk.

CEREMONIES AT GUILDHALL

It is the duty and privilege of Liverymen to attend Guildhall for the purpose of electing the Sheriffs and certain Officers on Midsummer Day and the Lord Mayor on Michaelmas Day. These ceremonies are colourful and interesting. Luncheon is available afterwards. Information may be obtained from the Clerk.

APPRENTICES

In recent years the practice of Liverymen taking apprentices has been revived. This amounts to a friendly binding between a Liveryman and, normally, a young relation. It serves to introduce the apprentice to the practices of the Company. Apprentices qualify to become freemen of the Company and, subject to interview and payment of fine, to be elected to the Livery as well. The Clerk will be pleased to supply further particulars on request.

FREEMEN

Liverymen with children or grand-children, between the age of 18 and 35, are encouraged to enrol them in the Company as Freemen. This will build up a pool of young and enthusiastic members who, in due course, might become Liverymen. Speak to the Clerk for details.

MASTERS' BOOK

A leather-bound book listing the names of all previous Masters of the Company was presented by Past Master, Keith L. Cobb. The name of the current Master is added each year. (The leather was kindly presented by Past Master Sir Kenneth Newton.

HMS LANCASTER

**AN INTERPRETATION OF THE ORIGINAL LETTERS PATENT GRANTED BY
JAMES I IN 1604**

JAMES, by the Grace of God, King of England, Scotland, France, and Ireland, defender of the Faith To all whom these present shall come, Greeting,

WHEREAS in the Parliament at Westmynster the first daye of September in the Eight yeare of the raigne of the late Queene Elizabeth Queene of England (1566) there was made an Acte for the true making of hatts and capps Whereof it was enacted that noe person worke anie felt or hatt with anie forraine wools inlesse such person shoulde fyrste have bine apprentice by the space of seaven yeares uppon payne to forfeyt such hatts and fyve poundes in money.

AND further that noe person should retaine in the said arte of hatt or felt making anie person born out of our realms and dominions of England Scotland and Ireland uppon paine to forfeyte f'vyve poundes for everi moneth wherein such person offend.

AND WHEREAS there are in Cittie of London and the suburbes of the same aboute seaven thowsand persons of the said rnisterie of feltmakers whoe might be better governed incorporated subiecte to correction of men of the said arte that are best able to to discerne abuses of the same.

AND WHEREAS for those intents and purposes our well beloved subiects the feltmakers of our Cittie of London and the suburbs within the space of fower miles distante have made humble supplication unto us that they maye be incorporated byn the name of Master Wordons and Comunalitie of the misterie or arte offeltmakers of London.

KNOW YE THEREFORE that we have declared that all being feltmakers and now dwelling within our said Cittie of London and the suburbs not above fower myles distant from henceforth be for ever one bodie corporate by the name of Master Wordens and Comunalitie of the Arte or Misterie of Feltmakers of London. WE doe ordaine by these present that by the same name they be capable in law to hold and enjoye anie mannors landes tenements liberties franchises rentes reversiones privileges and other hereditaments in fee to them alsoe all goodes chattels and other things whatsoever.

THE said Master Wordons and Comunalitie maye have for ever a common seale to serve for the ensealing of all causes and that it shall be lawful for the said Master and successors the same seale to breake deface and make newe and wee do grant by these present from henceforth there shall be one Master and fower Wordens and twelve assistants of the Feltmakers of London to be yearelie constituted.

WE doe ordaine our well beloved subiect JOHN SONDS feltmaker of our Cittie of London to be the first Master and doe name our well beloved subiects John Harrison, Richard Daunester, Lewes Price and John Tomlin feltmakers of London to be the firste foure Wardens. For the better assistance of the said Master and Wardens we doe assign James Wanford, John Lowe, Hughe Phillipps, John Watson, Robert Sadler, Richard

Fford, John Tutt, Anthony Huchins, Robert Crowne, Owen Davies.

Thomas Lee and Abraham Lambert feltmakers of London aforesaid to be the first and present twelve assistants of the said Arte duering their naturall lyves ayding counselling or assisting unto the said Master for the better establishment of all reasonable and holosome ordinances whatsoever concordant with the lawes and statutes of this our said Realme of England

ON the morrowe nexte after the feast of the Nativitie of the Blessed Virgin Mary yearelie hereafter the Master and Wardens of the Feltmakers be assembled at a convenient house or hall within the Cytie of London and shall nominate fyve able and sufficient men of the assistants and ymmediatelie upon the same daye electe and choose one to be Master

THE SAID MASTER WARDENS and COMUNALTIE of Feltmakers may have one house and a stret person in manner to be chose and named the Clerke AND we have ordeyned our well beloved subiecte NICHOLAS RABIE gentleman to be the first and present clerke and one other honest and discrete man to be clerk after the death of the said Nicholas Rabie or surrender of the said Office.

Yt shall be lawful as often as shall seeme needful to congregate at their hall or house to constitute and make ordinances which to them or the greater part of them shall seem reasonable profitable and requiste

WE have geven to the Master of the Feltmakers that yt shall be lawful for the said Master and Wardens or anie two of them together with anie twoe of the Master Wardens and fellowshippe of the Haberdahsers in the Cittie of London to search all persons making here- after in anie manner hats or felts and shall make their corrupt wolls, that is to saie , maie woll rotten woll and woll falsly and deceitfully packed in any place within our said Cittie of London or mingled in the deceitful making or workmanshippe of anie manner of hats or felts to the prejudice of our loving subjects TO SEIZE TAKE and SIPOSE OF according to the laws and statutes of this our Realme

PROVIDED that this shall not be construed to the prejudice of the Haberdahsers but that they shall soe ever hereafter have and enjoy such priviledges as they lawfullie enjoyed before the making of these Letters Patent under the Greate Seale of England.

AND FURTHER we have graunted unto the said Feltmakers of London speciall licence that they may receive and purchase manors mesuages lands tenements rectories tithes rents revenues possessions reversions and other hereditaments whatsoever which are not held of us our heirs or successors in chiefe or by knights service soe that the same doe not to exceed in the whole the cleare yearlie value of twentie poundes.

IN WITNESS whereof myself at Westminster August (1604)
